Aurukun Shire Council, Rio Tinto, Chalco, Wik Way traditional owners, or agents or employees of these parties will not be held liable for any actions, events, loss or damage arising from use of Wik Way traditional lands for any purpose including, but not restricted to, those specified under this permit, even if aforesaid actions, events, loss or damage result from negligence on the part of those parties.

Do not clean fish in the vicinity of the camping area. Remember crocodiles are in these waters, it may not get you, but it might get the next person.
