5.2 Aurukun/Weipa Travel Restrictions Update

On Friday 24 April 2020 Biosecurity (Human Biosecurity Emergency) (Human Coronavirus with Pandemic Potential) (Emergency Requirements for Remote Communities) Determination 2020 was amended.

Amendment provides for inclusion of Weipa Township area in Biosecurity Zone. Travel restrictions between Aurukun and Weipa will now be allowed for essential travel purposes only.

5.3 Koolkan Aurukun State School Attendance Report

Email received on Thursday 23 April 2020 from Paula McGuire, Principal of Koolkan Aurukun State School advising Mayor and CEO of the school's attendance for the first week of term.

She advises that attendance for the first week of school term is going well so far.

Numbers are down in comparison to term 1 where we regularly saw 90 plus students. There has only been one family who have reported absences related to COVID-19. We are supporting another family by sending work home due to the household having a vulnerable person at home. The letter that you both saw went out to families on Monday and Tuesday with our current newsletter. We placed posters up at services advertising that we were re-opening and did a Facebook post about it.

All boarders have been supervised here this week, but we are hoping to have two learning venues next week to provide more supervision time. Students can access breakfast and lunch through our school food program. Sandy will organise a visit to the Training Centre with a view that it could be used as a venue for some of the boarding students.

IKC and Flexi Program

This morning our Guidance Officer and a staff member from our Wellbeing room sat outside the IKC to support any students. Unfortunately, none arrived but we will continue to provide a staff member to provide literacy and numeracy lessons to any Flexi students until Noel Waterman returns from quarantine in Cairns.
