### Points raised were:

- Lots of alcohol in the town, in particular last night.
- A couple of incidents at Tal Tal Street in the past two weeks between two clans that have an issue with each other. Mediation to happen in the coming weeks.
- More serious crimes that child protective services are investigating with positive outcomes.
- Repeat offenders.
- Since Brett Jenkins has arrived and he has been a positive influence on the police station in respect to the court proceedings etc. Three more staff are to arrive for the Christmas period.
- Funding approved through to the middle of 2018 and a number of duplexes to be constructed at the police precinct. Increase in foot patrols around the business precinct during business hours. This will hopefully lead to a decrease in the intoxication of the community.
- Boats being used inappropriately within the community to transport alcohol. Boat patrols have increased by the police department.
- A number of people coming into the community who have very weak ties and are breaking the law. What is the ASC stance on them coming into the town? Would the ASC support a banning on them returning to the community? QPS is looking for the support of the ASC to ban repeat offenders. CEO recommends the QPS to supply an example of what they are needing and we can put it to Council.
- CCTV working group ASC would like feedback on the footage. Invaluable for the QPS as a large portion of the crime within the community has been solved with the help of the CCTV. Day time CCTV is great however the CCTV at night is hard to identify offenders. Is there the ability to have infrared installed on the cameras?
- Assistant Commissioner Paul Taylor will be attending the PCYC opening.
- Court Dates were provided by QPS
- QPS to identify black spots within the community. DTS requested the QPS inform ASC on any lighting around the town that may be out so that ASC can request Ergon to rectify.
