### 2.14 Discussion of ASC 2020 Goals in the current COVID-19 crisis

Mayor and Councillors noted that in future they should discuss ASC Goals for the remainder of 2020 particularly in view of the COVID-19 crisis.

ASC Directors advised Council on how COVID-19 situation is affecting their departments.

Gus Yates, Director Technical Services advised that:

- current situation was impacting on deliveries for road works as many suppliers are affected by travel restrictions for road freight
- there is limited staff to undertake building maintenance and repairs and contractors are assisting with these tasks
- airport operations has slowed as Skytrans has reduced the amount of flights coming in.

Andrew Brown, Acting Director Corporate Services advised that:

- supply providers were taking longer than normal to supply items due to current situation and travel restrictions
- half the Cairns Support Office staff and one Aurukun Staff member are currently working from home
- Bank and Post Office are still operating on normal opening hours. Social distancing is being practiced.

Alan Neilan, Director Community Services advised that:

- Koolkan Early Childcare Centre is currently closed for holiday break. Will reopen on 20 April 2020 for children of essential personnel only.
- · Community Centre, IKC and Splash Park are all closed
- Koolkan Playgroup closed although the Program Coordinator has put together programs that the children can do
- Music Festival has been postponed. Anzac Day laying of wreaths will be by invitation due to restrictions on social gathering and distancing.
- Chivaree Centre is operating with limited services
- Strict government regulations on social gathering restrictions mean Funeral Services will be delayed. Arrangements are in place for funerals to be conducted when restrictions have been lifted.

Mayor then spoke to the Councillors about the need to advise local residents of the current entry permit system and the ongoing government restrictions.
